Terms of Membership

- i. Membership Year is 1st January to 31st December.
- ii. Rates, other than for Distance Member, are inclusive of GUI/ILGU levy and insurance.
- iii. Ex MGC Full Member is a person who has previously been a Full Member of Mitchelstown GC and held a GUI/ILGU handicap but will not have been a member of MGC for the previous 3 years.
- iv. New Full Member means a person who has been a member of another golf club and held a GUI/ILGU handicap elsewhere.
- v. Novice means a person who has not previously been a member of a Golf Club or held a GUI/ILGU handicap.
- vi. Up to age 31/ 41 rates exclude the year with 31st and 41st birthday respectively.
- vii. Where a Former, New, Novice or Zone 2 member on Year 3-5 of reduced rates is under age 31/41 or Zone 2, the lower Age or Zone €35/€45/€50 monthly DD rate (plus Capital Levy) will apply.
- viii. Direct Debit deductions commence from month of membership entry – 12 per yr. Direct Debit rates are per person.
- ix. To be eligible to compete in and win prizes in club competitions, Membership Subscription must be paid in full or Direct Debit mandate approved by member's bank before 1st March of Membership Year.
- x. Committee will require proof of address for some membership categories
- xi. Distance Members are eligible to compete in but cannot win the Captain's Prize or President's Prize,
- xii. In the event of missed direct debit monthly payment, member may restore their membership by paying the outstanding balance within 3 months.
- xiii. Former, New or Novice member on time limited rates may apply for a years' leave of absence, and if granted the reduced rate period will be extended by the leave of absence period.
- xiv. In the event of non-payment of single payment or direct debit subscriptions, membership will be terminated per the constitution of Mitchelstown Golf Club.
